

## TRADEMARK LICENSE RESTRICTIONS

UA has granted you or the entity you represent (as applicable, the “Authorized Licensee”) the right to use certain trademarks or service marks (each, a “UA Marks”), as specified in a separate agreement (the “Agreement”) that incorporates these Trademark License Restrictions by reference. In consideration for the right to use each UA Mark, the Authorized Licensee hereby agrees as follows:

1. **Scope of License.** Authorized Licensee shall use each UA Mark only in accordance with the terms and conditions set forth in the Agreement and these Trademark License Restrictions, as such documents may be amended from time to time in accordance with their respective terms. The Agreement and these Trademark License Restrictions, as so amended, are hereinafter referred to as the “Trademark Terms”. And the usage rights granted in the Trademark Terms are hereinafter referred to as the Permitted Uses”.

2. **Form of Use.** Authorized Licensee shall use each UA Mark only in accordance with the Brand Guidelines set forth at [www.uaudio.com/press/resources/logos.html](http://www.uaudio.com/press/resources/logos.html) or otherwise approved in writing by UA (together, the “UA Brand Guidelines”). Authorized Licensee shall include, where appropriate, the designations ® or ™ and a statement that the UA Mark is the trademark of UA, and such other proprietary notices as reasonably required by UA from time-to-time. Authorized Licensee shall comply with all applicable laws and regulations pertaining to the proper use and designation of trademarks in each country in which Authorized Licensee uses the UA Mark.

3. **Obligations of Authorized Licensee.**

a. **Limited Purpose.** Authorized Licensee shall not use any UA Mark in connection with any activity that is not Permitted Use, except with the prior written approval of UA.

b. **Quality Control**

(i) **High Quality.** The nature and quality of all services rendered by Authorized Licensee and all goods sold by Licensee in connection with each UA Mark and all advertising and promotional uses and all other related uses of the UA Mark by Authorized Licensee must be of the highest standards of product quality, honesty, integrity, fair dealing and ethics conforming to standards set by and under the control of UA.

(ii) **Quality Control.** UA shall have the right to monitor the quality of the services provided by Authorized Licensee and the depiction of each UA Mark, and Authorized Licensee shall assist UA in monitoring quality by providing to UA customer communications expressing customer satisfaction or complaints with respect to the Permitted Uses. Authorized Licensee shall undertake such other steps as UA may reasonably request to assist UA in monitoring the quality of the services provided by Authorized Licensee under each UA Mark. UA has the right to take all action which it deems necessary to ensure that the Authorized Licensee's activities under and uses of each UA Mark are consistent with the reputation for quality and prestige of such UA Mark.

(iii) **Samples.** Authorized Licensee shall make available to UA, for its approval, samples of all uses of each UA Mark on web site pages and on and in promotional materials. UA shall have the right to make reasonable objections to any such sample on the grounds that UA believes that the use of such materials by Licensee will be damaging to the value of, or reputation associated with, the UA Mark, be dilutive of the UA Mark or fail meet the standards of quality required for the UA Mark. UA shall exercise its approval rights in good faith and any request for modification of a submission shall include an adequate explanation.

(iv) **Compliance with Law.** Authorized Licensee shall comply with all applicable laws and regulations and obtain all appropriate government approvals pertaining to its sale, distribution and advertising of the goods and services under each UA Mark and shall not do or suffer to be done any act or thing that would impair UA's rights in the UA Mark or damage the reputation for quality inherent in the UA Mark.

c. **Confusingly Similar and/or Combination Marks** . Licensee shall not adopt or use any other trademark, word, symbol, letter, design or mark: (i) in combination with any UA Mark in a manner that

would result in a new mark creating a separate commercial impression from the UA Mark (a "Combination Mark"); or (ii) that is confusingly similar to the UA Mark.

d. **Indemnity by Authorized Licensee.** Authorized Licensee shall defend, indemnify and hold UA harmless from and against any liabilities, losses, claims, damages, costs, expenses (including without limitation reasonable attorneys' fees) arising out of or in connection with promotion, marketing and distribution of goods and services under each UA Mark. UA shall (a) promptly notify Authorized Licensee in writing of any such claim; (b) permit Licensee to assume sole control of the defense or settlement of such claim, subject to Licensee's cooperation with UA to protect the reputation for quality and integrity associated with the UA Mark; and cooperate with Authorized Licensee, at Authorized Licensee's expense, in defending or settling such claim. UA may join in defense with counsel of its choice at UA's expense. Authorized Licensee may not settle any claim without UA's consent.

#### 4. **Ownership**

a. **Ownership of UA Marks.** Authorized Licensee acknowledges that it has no interest in any UA Mark other than the licenses granted under this Agreement and that, as between UA and Authorized Licensee, UA will remain the sole and exclusive owner of all right, title and interest in all UA Marks and all applications, reissuances, divisions, re-examinations, renewals or extensions thereof. Authorized Licensee agrees that sales and services by Authorized Licensee will be deemed made by UA for the purposes of trademark registration and that Authorized Licensee's use of each UA Mark will inure solely to the benefit of UA and will not create any right, title or interest for Licensee in any UA Mark.

b. **No Contest.** Authorized Licensee shall not contest, oppose or challenge UA's ownership of any UA Mark. Authorized Licensee agrees that it will do nothing to impair UA's ownership or rights in any UA Mark. In particular, Authorized Licensee shall not register or attempt to register any UA Mark in any jurisdiction and will not oppose UA's registration of any UA Mark, alone or with other words or designs, in any jurisdiction. If Authorized Licensee uses, registers or applies to register a UA Mark that violates its obligations under this section, Authorized Licensee agrees, at UA's request, to abandon the use of such UA Mark and any application or registration for such UA Mark.

c. **Adverse Use .** Authorized Licensee shall promptly notify UA of any adverse use by a third party of any UA Mark or of a mark or name confusingly similar to the UA Mark. Authorized Licensee shall take no action with respect thereto except with the prior written authorization of UA. UA may thereupon take such action as it, in its sole discretion, deems advisable for the protection of its rights in and to the UA Mark, including allowing Authorized Licensee to bring and prosecute a claim against such third party at Authorized Licensee's expense. Authorized Licensee shall fully cooperate with any legal or equitable action by UA to protect UA's rights in the UA Mark.

d. **Assistance.** Authorized Licensee shall assist UA in complying with any formalities to protect each UA Mark under foreign law, such as registering the UA Mark, registering this Agreement or filing as a registered user. Authorized Licensee shall execute any documents reasonably requested by UA, including, but not limited to, applications for registered user or additional licenses for recording with the appropriate authorities. Authorized Licensee may propose to UA in writing that additional applications for trademark or domain name registrations be filed. Such applications may be made at UA's discretion and at UA's expense. If UA does not undertake to initiate such any application proposed by Authorized Licensee within 30 days after receiving Authorized Licensee's request for such action, then Authorized Licensee may initiate, at Authorized Licensee's expense, in UA's name, the requested application. Upon termination or expiration of the license to use the UA Mark in a country to which this section applies, UA and Licensee shall cancel the registered user registration or recording of the Agreement in such country. Licensee shall execute any documents reasonably requested by UA to complete such cancellations.

5. **Amendment.** UA may amend these Trademark Terms, at any time, in its sole discretion. In such event, UA shall notify Authorized Licensee of the amendment using any method that UA deems necessary or advisable, in its sole discretion (such as posting the amendment on the UA Website).
